## Operational Excellence Awards

Egypt Oil & Gas Convention launched its first edition in January 2018 under the objective of promoting best practices and new technologies in the Egyptian oil and gas sector. Under the high patronage of H.E. Eng. Tarek El Molla, Minister of Petroleum and Mineral Resources, the eighth edition of the event, to be held in November, will focus on decarbonization and energy security.

The Convention is held annually as part of Egypt Oil & Gas Committee's vision of pushing the petroleum industry forward and helping Egypt in its ambition of becoming a regional energy hub.

This edition, Egypt Oil & Gas presents the Operational Excellence Awards to hand honorable recognitions within three categories. The submissions should highlight the outstanding performance of collaborative teams that brings the best operational projects developed in Egypt's fields. Two awards will be handed under each category.

Category 1: **Operational Excellence in Brownfield**

Category 2: **Highest Impact Decarbonization Project**

Category 3: **Best Economical Decarbonization Project**

We encourage you to submit an entry for the Operational Excellence Awards and enjoy the opportunity to have your best practices shared with industry leaders and decision-makers. Entries should be submitted within **October 29th, 2023**.

## Operational Excellence in Brownfield

### Submission Requirements

Eligible submissions should meet the following specifications:

- Approval of all companies management is required (JV, IOC, Service companies)
- Projects or practices submitted must be already concluded
- Projects/practices' monitored values and methods of calculation must be specified in the submission
- Multiple submissions are allowed
- Submission must be supported with graphs/images
- Entries must be in English
- You must identify teams, departments, or companies participated in your submission

### Selection Criteria

Individual and Project submissions will be evaluated under criteria. Each criteria has a different weight, as following:

Evidence of safe execution	15%
Business Impact	40%
Innovation	20%
Repeatability	15%
Teamwork and integration	10%

#### Evidence of safe execution – 15%

- Evidence of commitment to and record of safety for employees, environment and local communities.

#### Business Impact - 40%

- Submission clearly describes the overall financial impact generated by the project, documents measurable business impact and demonstrates the in-country value (ICV)

### **Innovation – 20%**

- Identification of inventive new technology or innovative implementation of existing technology, which represents a major new technology inventions or development in improving and progressing upon the current practices.
- Clear demonstration of what is original about the concept and the benefits of the innovation over existing methods.
- The submission maps out the before-and-after process improvements and clearly defines the core operating processes it will impact, made clear in terms of measurable results:
  - Process complexity reduction.
  - Time improvement in completing the process.
  - Cost improvements.
  - Quality or safety improvements.
  - Improved outputs from the process impacted.

### **Repeatability – 15%**

- Applicability to more than one project that allows it to be duplicated and reimplemented.

### **Teamwork and integration - 10%**

The submission sets out:

- Details on how the teamwork effectiveness was achieved and how the results of the collaboration are measured
- The inclusive, exemplary, or innovative aspects of the collaboration, promoting diversity as a value
- The positive impact of the collaboration on how teams work together in terms of performance, efficiencies, and cost optimisation.
